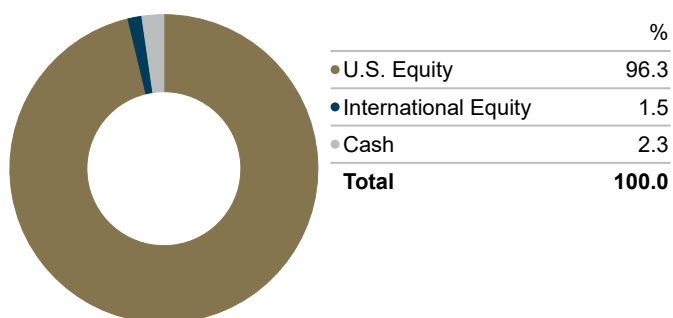

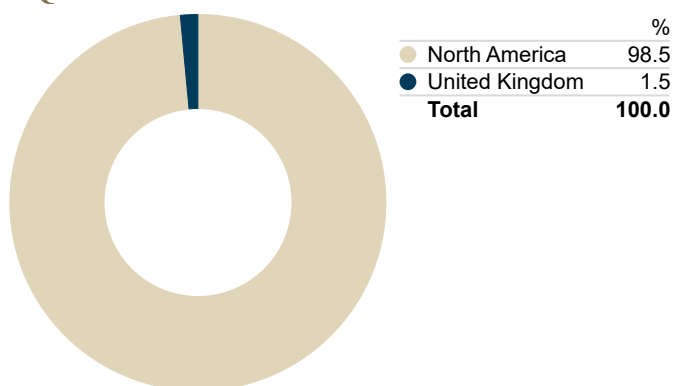

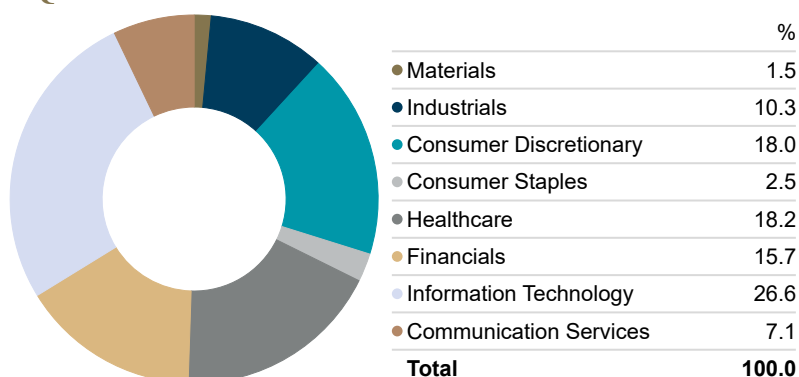
INVESTMENT PHILOSOPHY

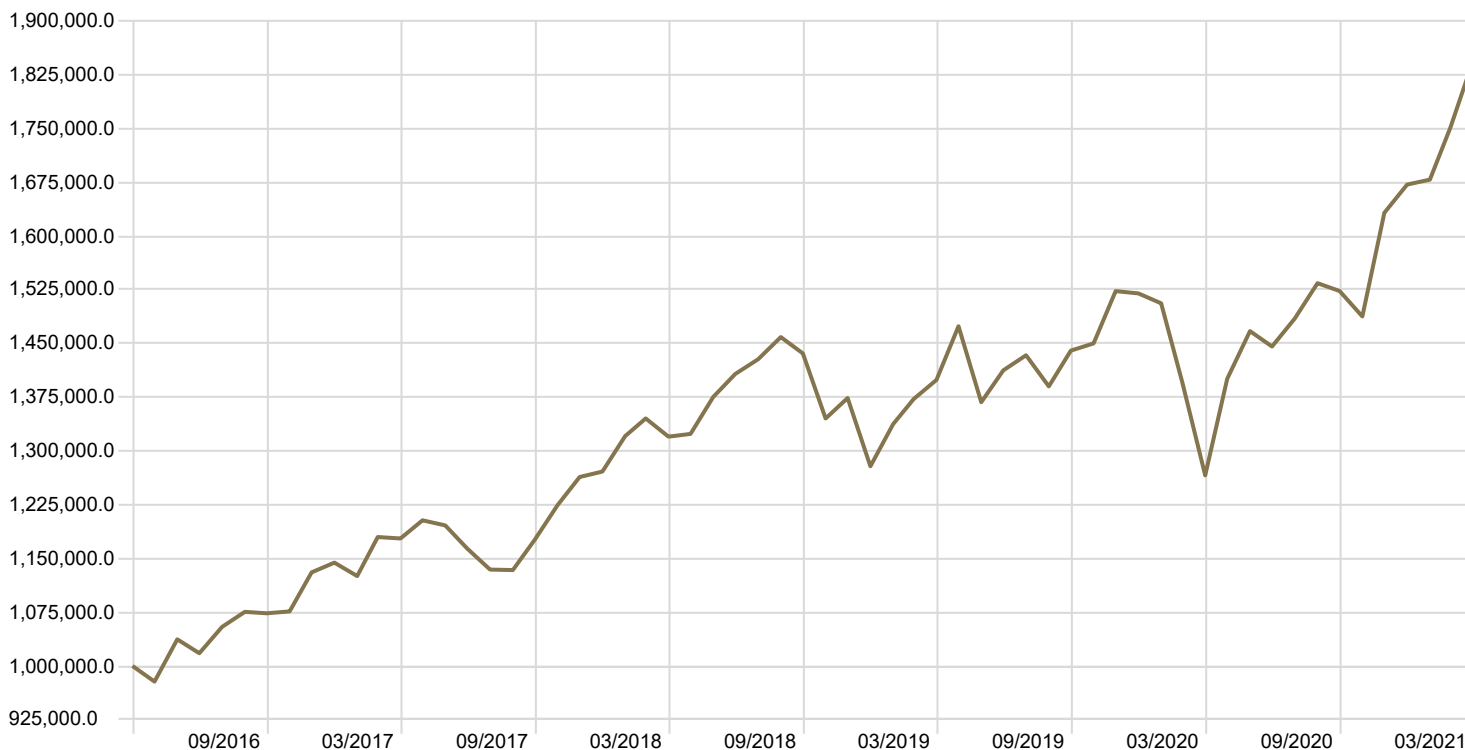
