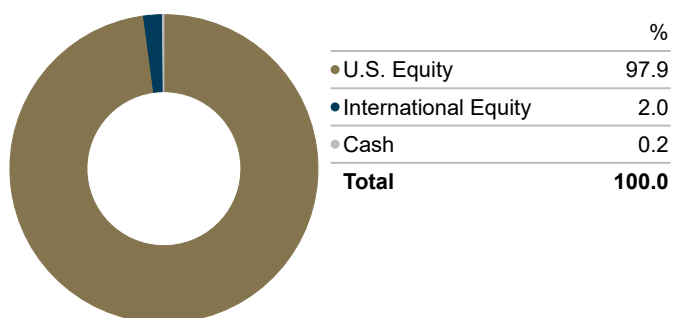

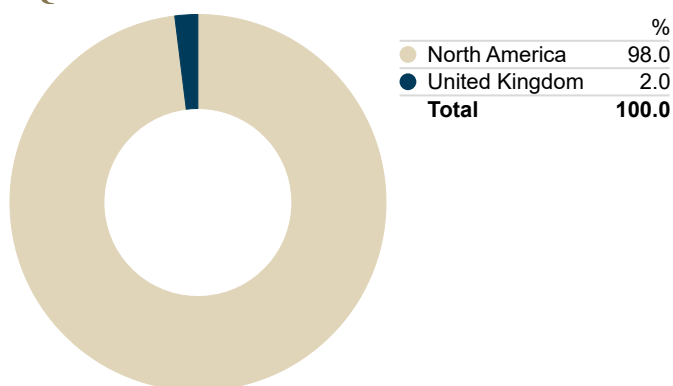

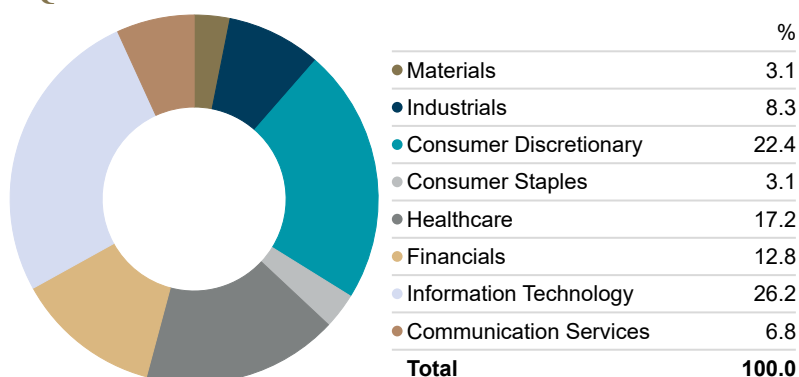
## INVESTMENT PHILOSOPHY
